Note: This section is not the license but an outline in a more simple and easy to ready way.

Once you have submitted the song through our form you are telling us you own all rights to the song if an original song., if it's a remix you are telling us you have full permission from the original artist to use the song, along with giving us permission to download and create audio/visual content to upload on selected platforms.

We will be releasing the song onto the following platforms YouTube, Soundcloud, Audiomack, Facebook, Our Website and any future platforms.

The submitted song can be used in other Content Creators YouTube & Streams or be used remixes to upload to YouTube under the conditions that credit is given to us and you.

If you release the song with another label or record, we advise you to give us notice within 48 hours of the song being accepted, or we will get in contact with you confirming information.

Any companies software or applications we use to look after the submission may have access to the information you are provided us.

Terms and Conditions Version 11

Definition and Interpretation

1. Unless mentioned or specified, the following is used in the below context:
You & Artist refers to the submitter.
Us, We & Our refers to Royalty Free Promotion.
Content meaning any audio found in the submission.
Free Download meaning the end product can be acquired at no cost.
Third Party meaning someone that was not directly involved in the making of the content.
Download Gate meaning any third party site at which the content can be acquired.
Content Creators meaning any other person that makes audio and/or visual content.
Platform meaning websites that can play audio/visual content.
Form refers to the song submission form.
2. The singular work include plurals and vice versa

Single and Collaboration Song Submissions

1. Upon submitting the following song you are implying that you own all rights to the content provided.
2. Any and all content that was provided does not violate the condition of any third party.
3. Upon submitting the song you are giving us licensing rights to the song.
4. By submitting the following song you are giving us the right to download and create audio visual content to upload onto selected platforms hereunder.
5. By submitting the following song you are giving us the right to display some or all of the links under the social media section in compliance to the Creative Attribution Sharealike 4.0 International License.

Remix Song Submissions

1. Upon submitting the following song you are implying that you have full permission use the content provided within the song.
2. Any and all content does not violate the conditions of any third party.
3. Upon submitting the song you are giving us licensing rights to the song.
4. Upon submitting the song you are giving us the right to download and create audio visual content to upload onto selected platforms hereunder.
5. By submitting the following song you are giving us the right to display some or all of the links under the social media section in compliance to the Creative Attribution Sharealike 4.0 International License.

Release of the Music

1. The submitted song will be released under the Creative Commons Sharealike 4.0 international License, with the condition that credit is given to you and us.
2. The submitted song will be released with a free download link through a download gate of our choice.

3. The following song will be posted on some or all of the following platforms, along with any future platforms we may release on: YouTube (www.youtube.com/c/royaltyfreepromotion), Soundcloud (www.soundcloud.com/royaltyfreepromotion), Audiomack (www.audiomack.com/artist/royaltyfreepromotion), Facebook (www.facebook.com/royaltyfreepromotion), Our Website (www.royaltyfreepromotion.com).

Use of Music by Third Parties

1. Other content creators will be able to use the submitted content in their YouTube Videos and Streams.
2. Other Content Creators will be able to modify the submitted song in part or in full.
3. If the submitted song is to be modified, the modified song is to be released under the same license and credit must be given to you and us.
4. The submitted song will be released for commercial and non-commercial use within YouTube only.
5. Any use of the submitted content outside of YouTube will need consent from you or us.

Release with Another Label/Record

1. Should the song be released under another label/record before our release, notification is advised but not needed within 48 hours of being accepted by the new label/record.
2. Should the song be released under another label after our release notification is advised but not needed within 48 hours of being accepted by the new label/record.
3. Should no notification be given, the song will be temporarily taken down and confirmation email sent out, after confirmation has been confirmed, the song will be put back up.

Privacy Information

1. All information processed through our form will be archived and can be accessed by employees we have.
2. Any third parties who's software, applications, or platforms we use to monitor submission, may be able to see/read/store this information
3. Companies that we currently use to monitor submissions are:
