The submitted song will be release as a free download, but we can arrange some paid download links to be put in place, however this is only available on selected platforms.

Once accepted the song will be released on YouTube, Soundcloud and Our Website.

The free download will be supplied on AudioGrab.

Should anyone want to modify t he song they will need to get permission from you.

Terms and Conditions Version 8

Definitions and Interpretation

1. Unless mentioned, required or specified, the following is used in the below context:
You and Artist refers to the submitter.
Us, We and Our refers to Royalty Free Promotion.
Content meaning any audio found in the submission.
Free Download meaning the end production can be acquired at no cost.
Third Party meaning someone that was not directly involved in the making of the song.
Download Gate meaning a third party site at which the song can be acquired at no cost.
Content Creators meaning any other person/s that make audio and visual content.
Platform meaning websites that accept songs.
2. The singular words include plurals and vice versa.

Single and Collaboration Song Submissions

1. Upon submitting the song you are implying that you are the owner of the content provided within the song.
2. Any content found within the song does not violate the conditions of any third parties.
3. Upon submitting the song you are giving Royalty Free Promotion the right to release the song under Creative Commons Noderivatives 4.0 International License.
4. The song will be release as a free download, paid download (only available on selected platforms can be arranged but a free download will be added as well).

Remix Song Submissions

1. Upon submitting the following song you are implying that you have full consent/permission to use the third parties song in full or in part.
2. Upon submitting the following song you are giving use the right to release the song under Creative Commons Noderivatives 4.0 International License.
3. The song being submitted will be release as a free download, paid download only available on selected platforms can be arranged but free download will be added as well.

Release and Use of the Music

1. Any content that is being submitted will be released under the following Creative Commons Attribution Noderivatives 4.0 International License.
2. The song will be displayed on YouTube (www.youtube.com/c/royaltyfreepromotion), Soundcloud (www.soundcloud.com/royaltyfreepromotion), Audiomack (www.audiomack.com/artist/royaltyfreepromotion), Facebook (www.facebook.com/royaltyfreepromotion), Our Website (www.royaltyfreepromotion.com) and the download gate Uptona (www.uptona.com).
3. The song being submitted will be released as a free download, paid download only available on selected platforms can be arranged but a free download will be added as well.
